**CLASS OF MEMBERSHIP DESIRED**

**DUES**

**Class 1-** Family membership for legally recognized union and all unmarried children under age 23. Such membership provides access and use of all club facilities, subject to additional charges for such things as golf carts and social events.

**\$130/monthly**

**Class 2-** Unmarried individual and all unmarried children under age 23. Such membership provides access and use of all club facilities subject to additional charges for such things as golf carts and social events.

**\$105/monthly**

**Class 3-** Social Membership (pool) consists of husband and wife or individuals over the age of 18. Unmarried children up to the age of 23 are authorized to use the facilities to the same extent as their parents. Such membership provides access and use of all club facilities and such member is entitled to pay fees for one round of golf monthly, anytime weekdays and after 12N on weekends.

**\$50/monthly**

**Class 4-** Out-of-town family membership-married men or women who reside outside a 20-mile radius of BCC. Such membership provides access and use of all club facilities subject to additional charges for such things as golf carts, and social events. Unmarried children up to the age of 23 may also use the club under this membership.

**\$90 Family / \$70 Single monthly**

**Class 5 –** Senior membership consists of members who are at least 80 years of age and whose age plus years of membership is 110 or greater.
